CHAPTER ONE

CHAPTER TWO

CHAPTER FOUR

NIGERIAN ELECTRICITY MANAGEMENT SERVICES AGENCY (NEMSA)

The Nigerian Electricity Management Services Agency is established to carry out the functions of Enforcement of Technical Standards and Regulations, Technical Inspection, Testing and Certification of All categories of Electrical Installations, Electricity Meters, and Instruments, to ensure the Efficient Production and Delivery of Safe, Reliable and Sustainable Electricity Power Supply and Guarantee Safety of Lives and Property in the Nigerian Electricity Supply Industry, and other allied industries/workplaces.

In line with the provisions of the NEMSA Act 2015 and Statutory Regulations, it is mandatory that All Electrical Installations in Power Plants / Stations, Transmission Networks / Systems, Distribution Networks/Systems, and other Allied Industries and Workplaces where Electricity is used; as well as all Electricity Meters and Instruments to be deployed in NESI, are duly Inspected, Tested and Certified fit and safe by electrical inspectors (Engineers and Technologists) of NEMSA and the NEMSA National Meter Test Stations before they can be put to use in Nigeria.

CHAPTER FIVE

NIGERIA BULK ELECTRICITY TRADING PLC (NBET)

The Nigerian Bulk Electricity Trading (NBET) PLC is the central pooling agent ('The Pool') in the Nigerian electricity supply industry (NESI). The first in sub-Saharan Africa; it was incorporated on the 29th day of July 2010 and is 100% owned by the Federal Government of Nigeria.

NBET purchases electricity by Power Purchase Agreement (PPAs) from generators who inject their supplies from locations across the grid and are centrally dispatched from the National Control Centre (NCC) located at Oshogbo in Southern Nigeria. NBET resells the electricity it purchases to its customers who take electricity directly from the transportation system at 132/32 kv.

Our customers include generation companies who were created at the time of privatization from the assets of the former vertically integrated and government owned monopoly, the Power Holding Company of Nigeria (PHCN); Independent Power Producers (IPPs); distribution companies and large general service customers.

MANDATE

NBET purchases electricity from Generation Companies through Power Purchase Agreements (PPAs); and uses Vesting Contracts (VC) to resell to Distribution Companies and other large general service customers who take electricity from the transmission system. The Generation Companies include the 6 that were created out of the assets of the former government owned and vertically integrated monopoly utility - the Power Holding Company of Nigeria (PHCN); 10 companies that make up the National Integrated Power Project (NIPP) under a holding company – the Niger Delta Power Holding Company (NDPHC); existing Independent Power Producers (IPPs) such as Ibom Power, Okpai, FIPL, & Shell and new IPPs.

We also maintain regional customer relationships through two interconnectors, one in the North Western part and another in the south Western part of the country.

CHAPTER SIX

NIGERIA ELECTRICITY LIABILITY MANAGEMENT LTD/GTE (NELMCO)

The Nigeria Electricity Liability Management Ltd/Gte is an agency under the supervision of the Federal Ministry of Power which was created under the Electricity Power Sector Reform (EPSR) Act 2005 with the mandate to assume and administer the Electricity Power Sector Reform stranded debts and assets of PHCN pursuant to the provisions of the EPSR Act 2005; assume and manage the pension liabilities of employees of PHCN; hold the noncore assets of PHCN; sell or dispose of or deal in any manner for the purpose of financing the payment of debts or other related matters. Other very important aspects of NELMCO's mandate is to take over the management and settlement of PHCN's Power Purchase Agreement (PPA) debts as may be determined by the National Council on Privatisation (NCP) from time to time; sell, mortgage, dispose of, deal in any manner of the property or assets of the company as may be expedient with a view to promoting its objectives; as well as do all such other things as are incidental or may be thought expedient to the attainment of the above objectives or any of them.

In pursuance of the above mandate, NELMCO is saddled with the responsibility of developing and facilitating the implementation of policies for the settlement of all PHCN liabilities following the Power Sector Reforms.

- To administer the wholesale electricity market including settlement payment in accordance with the market rules
